### HG smelly washing machine cleaner

Washing machines do not always smell terribly fresh and at times they simply stink. Grease deposits and the remnants of liquid or powder detergents in the drains, on the filters and rubbers are the cause. HG "smelly washing machine cleaner" cleans the entire washing machine extremely effectively and produces a clean and fresh washing machine.

Directions for use: Make sure there is no laundry in the washing machine. Use a measuring cup to add 110 gram (approx. 100 ml) HG "smelly washing machine cleaner" to the main detergent tray. Rinse the measuring cup properly after use. Do not add any detergent. Set the programme to dark laundry at 60°C, without a pre-wash. Switch on the washing machine and let the programme complete without interruptions, including spinning. Recommended frequency: 1x every 4 weeks or more often if required.

Attention: If the washing machine continues to smell after using this product, or the smell returns within 1 or 2 days, we recommend cleaning it thoroughly with HG "service engineer".
